13.1 Adoption of Reinvestment Fee. The Association hereby adopts a Reinvestment Fee. The amount of the Reinvestment Fee shall be \$350. The Reinvestment Fee shall be paid by the purchaser of a unit whenever a unit is sold, transferred or conveyed to a new owner.
