### NOTICE OF REINVESTMENT FEE COVENANT

Pursuant to Utah Code Section 57-1-46, Winston Park Homeowners Association Inc. ("Association") hereby gives notice that the property in the Winston Park Property, located in Weber County, Utah, and more particularly described in Exhibit A attached hereto, ("Property"), is subject to a reinvestment fee covenant. As set forth in Section 5.15 of the Declaration of Covenants, Conditions, and Restrictions for Winston Park, recorded of even date herewith, the reinvestment fee covenant obligates a buyer of a Lot or parcel in the Property to pay a reinvestment fee upon the transfer of a Lot or parcel.

1. The fee must be paid to the Association at the Association's address as identified with the Utah Division of Corporations.
2. The amount of the fee is 0.5% of the purchase price of the Lot or parcel at the time of closing, or a lesser amount as may be established by the Association's Board of Directors from time to time.
3. The fee is required to benefit the Property or common area related thereto.
4. The purpose of the fee is to enable the Association to pay for the items identified in Utah Code Section 57-1-46(1)(i)(ii)(A)-(H), as may be amended or supplemented from time to time.

The reinvestment fee covenant shall perpetually run with the land and bind all successors in interest and assigns. The reinvestment fee covenant precludes the imposition of an additional reinvestment fee covenant related to the Property.

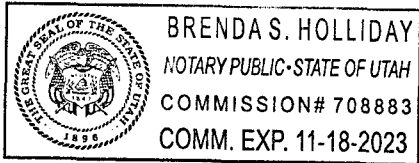
