2. The burden of the Covenant is intended to run with the land described in EXHIBIT A (the "Property") and shall bind all successors in interest and assigns, as provided by Utah Code § 57-1-46(3). It shall remain in effect unless properly amended, terminated, or otherwise rendered unenforceable by law.

3. As of the record date of this Notice, a reinvestment fee of \$495 shall be charged in accordance with Article IV(9) of the Declaration. This amount shall be paid by the buyer of the burdened property unless otherwise agreed in writing by both the buyer and the seller. This fee is separate from, and in addition to, any pro rata share of Association assessments due and adjusted at settlement. The existence of this Covenant prohibits the imposition of any additional reinvestment fee covenant on the burdened property. The purpose of the fee is to support the maintenance, repair, and improvement of common areas, facilities, and infrastructure and to contribute to the Association's reserve funds, ensuring the collective benefit of all properties within the community, including the burdened property.


